- 1. The Exhibitor agrees to register a 10' x 8' space. The space includes 10'x8' booth with pipe & drape, electrical hookup, WiFi internet access, 6' table, 2 chairs, breakfast, lunch, and listing in the event directory.
- 2. Location of Exhibitor's booth space will be determined by The Power Factory Ltd. Best efforts will be made to provide the Exhibitor's preferred booth location.
- 3. The Exhibitor is responsible for the security of their goods against all perils, at all times, including setup, exhibition hours, and take-down of their display.
- 4. The Exhibitor agrees to staff their display at all times during the event.
- 5. Exhibitor display set-up time is Feb 18th, 12pm-5pm or Feb 19th, 6:00 am 7:30 am.
- 6. Exhibitor display take-down is after 4pm on Feb 19th, 2019.
- 7. The Exhibitor is responsible for removing all goods and materials from the exhibitor floor after the event, and leaving the space rented in a clean and orderly state.
- 8. The Power Factory Ltd shall not be liable in any way for any damages or consequential injury of any nature whatsoever sustained by the EXHIBITOR or any employee, invitee, agent, or customer or any other person who may be on the registered space at the Pearson Convention Center, or for loss or damage or injury to any property belonging to the EXHIBITOR or employee, invitee or agent of the

- EXHIBITOR or to any other person whose property is on the registered space or in the Pearson Convention Center

The EXHIBITOR hereby agrees to, and, shall indemnify and hold harmless The Power Factory Ltd. from and against any and all claims, including without limitation, claims for personal injury or loss or damage to property arising from or out of any matter whatsoever which occurs as a result of the EXHIBITOR's action or inaction in connection with the operations of the Expo.
